**Note:** If you choose Option 1 or 2, we may help you to use any other insurance that you might have, but Medicare cannot require us to do this.

**G. OPTIONS: Check only one box. We cannot choose a box for you.**

- OPTION 1.** I want the **Guardant360<sup>®</sup> CDx Test** or **Guardant360<sup>®</sup> Test** listed above. You may ask to be paid now, but I also want Medicare billed for an official decision on payment, which is sent to me on a Medicare Summary Notice (MSN). I understand that if Medicare doesn't pay, I am responsible for payment, but **I can appeal to Medicare** by following the directions on the MSN. If Medicare does pay, you will refund any payments I made to you, less co-pays or deductibles.
- OPTION 2.** I want the **Guardant360<sup>®</sup> CDx Test** or **Guardant360<sup>®</sup> Test** listed above, but do not bill Medicare. You may ask to be paid now as I am responsible for payment. **I cannot appeal if Medicare is not billed.**
- OPTION 3.** I don't want the **Guardant360<sup>®</sup> CDx Test** or **Guardant360<sup>®</sup> Test** listed above. I understand with this choice I am **not** responsible for payment, and **I cannot appeal to see if Medicare would pay.**

**H. Additional Information:**

Your clinician has ordered a **Guardant360<sup>®</sup> CDx Test** or **Guardant360<sup>®</sup> Test**, which may help your clinician select the right drug to treat your cancer. If you have picked Option 1, Guardant Health will attempt to contact you to assess your eligibility for financial assistance and will provide you the opportunity to cancel the order for the Laboratory Test.
